

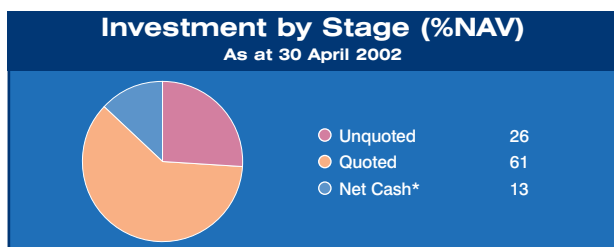

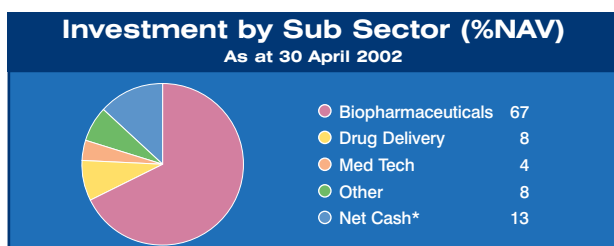

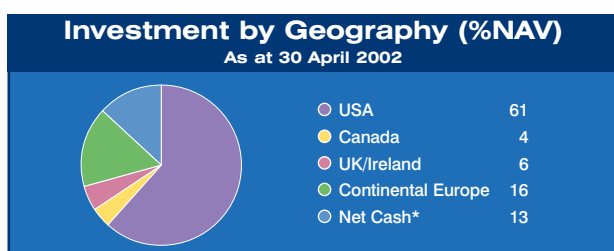
The investment objective of IBT is to achieve long term capital growth by investing in high growth, development stage biotechnology companies. IBT invests in companies that are undervalued and/or under-resourced, with experienced management and strong potential upside through the commercialisation of a product, device or enabling technology.



Up to approximately 25% of the portfolio may be invested in unquoted companies.



Approximately two-thirds of the portfolio will be invested in biotechnology with the remainder in other high growth life sciences sectors.



Approximately two-thirds of the portfolio to be invested in North America and one-third in Europe.
