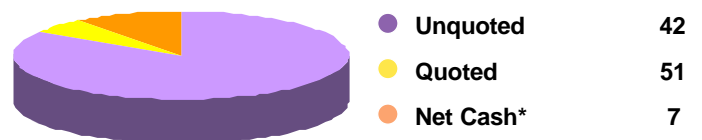

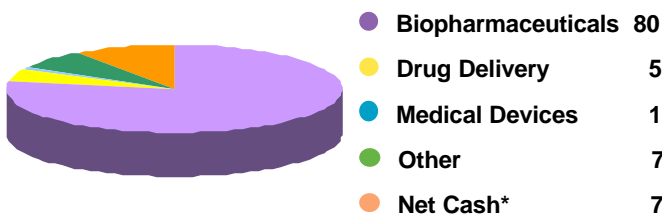
### Unquoted/Quoted Split (%NAV)

As at 31 August 2003



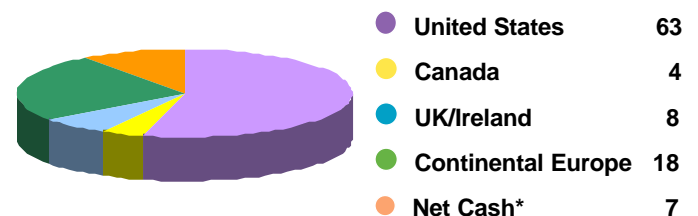
### Sector Split (%NAV)

### Geographical Split (%NAV)

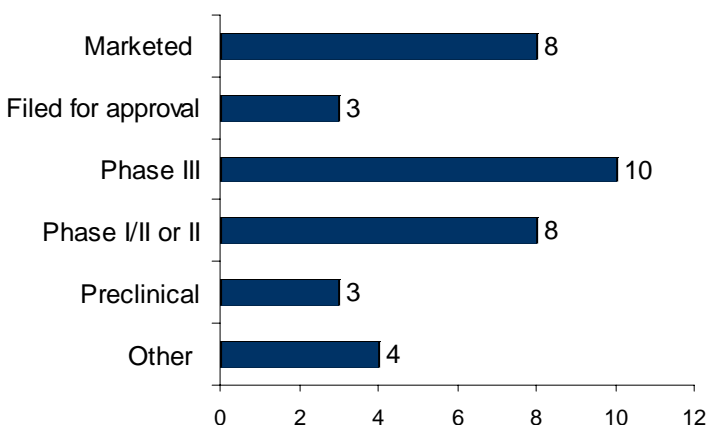

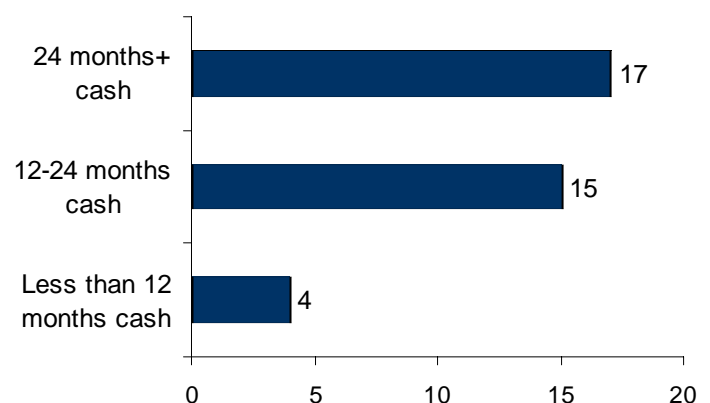
### Number of investments by stage of development of most advanced drug candidate
