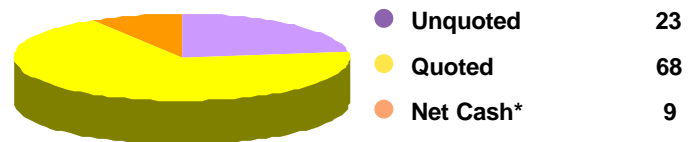

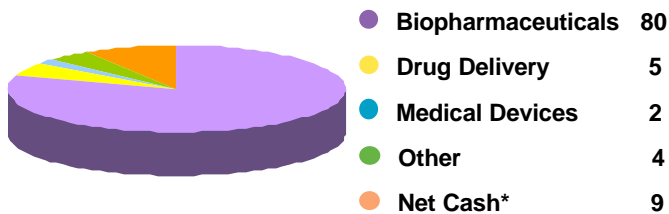
Unquoted/Quoted Split (%NAV)

As at 30 April 2004



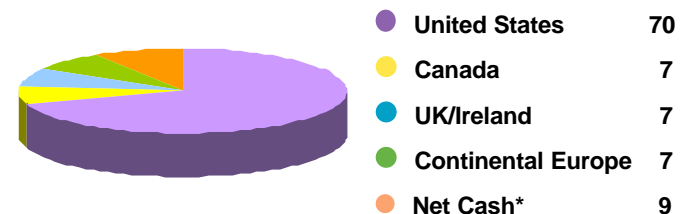
Sector Split (%NAV)

Geographical Split (%NAV)

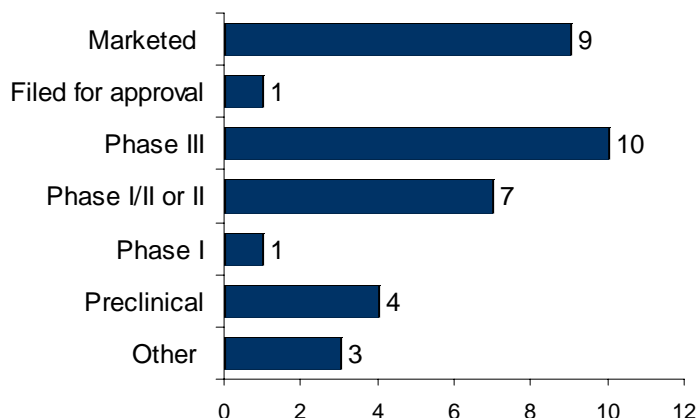

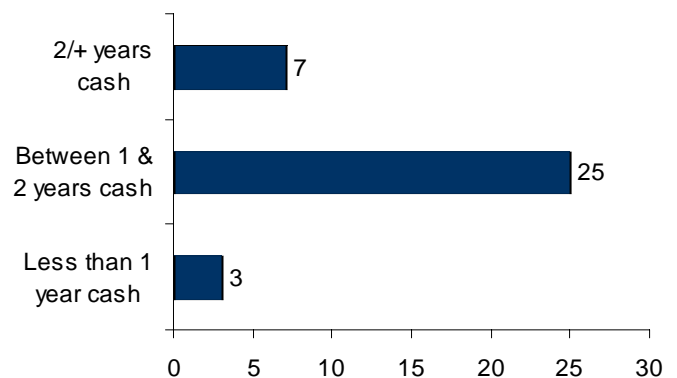
Number of investments by stage of development of most advanced drug candidate
